NDE Recommendation for MAP Growth in 2021-22

- Districts should review the information about the linking study. District leadership should discuss the pros and cons of proceeding with MAP Growth in the winter and spring of 2021-2022.
 - If your district relies upon MAP Growth data for any processes, consider giving MAP Growth in 2021-22 since NSCAS Growth will not yet be fully operational.

MAP Growth K-2 and 9-10

• In addition to MAP Growth for grades 3-8, NDE will be funding MAP Growth for K-2 and 9-10 for the 2021-2022 school year

Test Window 1

- Standard Administration (Paper): March 22, 2022
- Accommodations Administration (Paper): March 22-25 & March 28-31 & April 1
- Standard & ACT-Authorized Accommodations (Online): March 22-24 & March 29-31

Test Window 2

Standard Administration (Paper): April 5, 2022

Accommodations Administration (Paper): April 5-8 & April 11-15

Standard & ACT-Authorized Accommodations (Online): April 5-7 & April 12-14

Test Window 3 Makeup Only

Standard Administration (Paper): April 19, 2022

Accommodations Administration (Paper): April 19-22 & April 25-29

Standard & ACT-Authorized Accommodations (Online): April 19-21 & April 26-28

Please remember that you will have a choice between the first two assessment windows. Any subsequent window could be used for makeup testing. The third window (April 19) is makeup only.

NSCAS Science Spring 2022

NSCAS General

- Operational Test for grades 5 & 8
- Task Based
- Standard Setting (Cut Scores) Summer of 2022
- Formative Task Repository (additional grades coming soon!)

NSCAS Alternate

- Operational Test for 5th, 8th, & 11th Grades
- Similar to ELA and Mathematics (Match Items with Common Prompt)
- Standard Setting (Cut Scores) Summer of 2022
- <u>Extended Science Standards</u> for non-tested grades, Coming Soon!
- Instructional Supports Coming Soon!

NSCAS Alternate 2021-2022

- Online test with printable paper option (you do not receive materials)
- Be sure IEP teams are using NDE guidelines to determine eligibility
- NE is nearing the federally mandated less than1% participation, but we will likely apply for a waiver again
 - Waiver process requires all districts to submit justification paperwork
 - Fall 2021 share with SPED Directors
- Third-year cohort students that qualify have to take this test
- Instructional Supports for science and math, Coming Soon!

NAEP 2022

• New NAEP Coordinator, Polly Bowhay

- Participation
 - Approximately 100 Nebraska districts will be selected
 - Sampled districts will be notified in late August/early September
 - Approximately 200+ Nebraska schools will be selected
 - Sampled schools will be notified in September
- Testing Window: January 24-March 4, 2022
- Reading/Math for all 4th and 8th grade in selected schools
- Civics and US History for a smaller set selected 8th grade schools
- School, teacher, student questionnaires & additional Covid 19 questions

Announced in fall of 2019

Evolution of NSCAS

 Combination of MAP Growth and NSCAS Summative

Adaptive through-year model

NSCAS Growth

- Allows measurement goals to be defined during the test administration based on prior knowledge about the student and knowledge gained within the current test
 - Maximum efficiency—stop asking questions about what students know and can do that we know the answers to and instead use that time to ask questions that still need answering
 - Actionable results tailored to each student—start asking questions that relate directly to what students and teachers need to know to improve instruction multiple times a year, not just annually

The Path Forward

2021-22: Preliminary transition


- NSCAS Growth pilot in winter; NSCAS Growth in spring
- MAP Growth recommended as well, as NSCAS Growth not yet operational

2022-23: Operational transition

- NSCAS Growth in fall, winter, and spring
- MAP Growth and NSCAS General Summative no longer needed



NSCAS Growth Research





- Study 1 (Spring 21): Linking study – establish item bank, statistical link
- **Study 2 (Winter 21/22):** NSCAS Growth pilot – validate model
- Study 3 (Spring 22): NSCAS Growth census – verify that score trends are consistent with both the linked RIT and NSCAS scale scores
- Operational (2022-23): If study outcomes are as expected, we will transition to operational NSCAS Growth in Fall 2022

NSCAS Growth Winter Pilot



Pilot Objectives

- Validate the Nebraska adaptive through-year model
- Experience the assessment and platform ahead of the spring census administration
- Provide feedback on test administration and reporting to support improvements



Caveats

- Pilot will not feature a complete suite of reports and tools
- Results may not represent the timing/turnaround expected in operational year
- Districts will need to decide if they should administer MAP Growth in the winter if scores are used for high-stakes decision-making or used with MAP Accelerator or other content connections

NSCAS Growth Winter Pilot Participation

- NSCAS Growth (Grades 3-8, ELA & Math)
- All students will be required to participate in a single assessment, either ELA or math
 - NDE will assign the assessments; students in the same school and class will take the same test for logistical ease
- Districts may opt to give students both assessments

Platform for NSCAS Growth

- New, enhanced platform neither the MAP Growth nor the NSCAS General Summative platform
- New platform aims to address feedback from NE educators regarding the existing platform:
 - Time spent creating test sessions
 - Difficulties transferring students between districts
 - Need for more flexible user roles
 - More streamlined approach to off-site testing (such as external programs)

New platform highlights

- Test Sessions can automatically be created by class information provided in the roster.
- In-platform ability to transfer students between districts and notifications to DACs when students have been transferred.
- Flexibility to differentiate between home school and testing site if different.
- Students will be grouped by testing status and shown as a percentage to easily identify testing progress.
- Accommodations/accessibility may be assigned automatically with roster upload.

NSCAS Growth Data

Information produced by NSCAS Growth

What	When
RIT scores, including access to national norms	Fall, winter, spring
Grade-level data based on indicators used to determine summative proficiency	Fall, winter, spring
Projected summative proficiency scores	Fall, winter
Official summative proficiency scores and classification	Spring

Remember that 2021-22 is a preliminary transition year, so MAP Growth could be administered if RIT is used for high-stakes decision-making or MAP Accelerator/curricular connections
